Toni Kan will join Louisa Uchum Egbunike for a discussion on the construction of Lagos in his writing, with specific reference to his crime fiction. Kan's novel *The Carnivorous City* was described by Helon Habila as a book which 'brings Lagos to life like no other book I have read', emphasizing the intimate knowledge of Lagos presented in the text. Toni Kan has described his own intentions in writing *The Carnivorous City*, expressing his desire to "write a love song to Lagos, which I have called home for the last 25 years. (...) the plan was to map Lagos in words, to provide readers with what you could call a Lagos forged out of words." Described as 'a story about love, family and just desserts but (...) above all a tale about Lagos', this conversation will discuss *The Carnivorous City* and Kan's current Lagos novel in progress, *Time Never Passes*, in relation to a tradition of writing Lagos in post-independence Nigeria.
